



## GAIA GLOBAL HEALTH DONORS PRIVACY POLICY

GAIA Global Health (GAIA) is committed to protecting the privacy of its donors, contacts, and website visitors. Personal information provided in any form, whether by mail, telephone, through website visits, derived from internal website tracking system, or in any other manner is carefully protected and is not sold or shared with any individuals or organizations outside of GAIA, nor does GAIA send donor mailings on behalf of any outside organizations.

**Personal Information**  
Personal information is collected when contact is made with GAIA through various means including the website, by mail, telephone, email or other means, request to subscribe to newsletters, announcements (press releases), through registration and/or attendance at GAIA events, in internal communications at GAIA or as a part of job application. Information is also collected when a donation is made directly or through a third party.

You are not required to provide any personal information unless you choose to do so. However, personal information is requested to properly enable donation transaction processing and for tax purposes. If you make a donation to GAIA, your name and address will be placed on our mailing list (including email) for delivery of occasional updates from GAIA.

**Email Addresses**  
Our website does not automatically recognize your email address. We ask for your email address on a number of pages within our site, but you may opt out of email newsletters at any time by clicking the unsubscribe link contained in the email.

**Credit Card Security**  
GAIA is grateful for the donations that help us continue our work. It is very important to us that your personal information remains secure. GAIA processes online donations through Classy.org. Where credit card information is sent directly to GAIA, the donations are processed securely using Authorize.net and hard copies are destroyed once no longer needed.

We protect credit card information forwarded to GAIA using a number of measures, such as encryption, access control, network firewalls, and physical security. When we work with other third parties to process credit card transactions, those third parties also use appropriate security measures to safeguard your privacy.

**Cookies and Website Tracking**  
GAIA currently does not use cookies on its website. However, we use Google Analytics in order to track and report website traffic.
